

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Appendix 6-Chief Local Elected Official Agreement and Appendix 7-Chief
Local Elected Official and Local Board Partnership Agreement of the Nineteen
Tribal Nations Workforce Investment Area Business Plan)**

RESOLUTION NO. 14-561

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the authority "to promote, protect and provide for public health, peace,**
3 **morals, education and general welfare of the Tohono O'odham Nation and its**
4 **members" and to "consult, negotiate and conclude agreements and contracts on**
5 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
6 **and other Indian tribes. . ." (Constitution, Article VI, Section 1 (c)(2) and Section**
7 **1(f)); and**

8 **WHEREAS, an Intergovernmental Agreement between the Tohono O'odham Nation and the**
9 **Arizona Department of Economic Security to provide the Nation with funds for**
10 **specific Workforce Investment Act ("WIA") employment and training programs**
11 **operated by the Education Department's One Stop Division became effective**
12 **April 1, 2013 to June 30, 2018 (Resolution No. 14-252); and**

13 **WHEREAS, the Intergovernmental Agreement requires the Nation's One Stop Divisions to**
14 **provide services in accordance with federal and state regulations and the most**
15 **current local area plan; and**

16 **WHEREAS, the Nineteen Tribal Nations Workforce Investment Area, the only tribal**
17 **workforce investment area in the United States, developed a local workforce**
18 **area Business Plan and appendices; and**

19 **WHEREAS, the Human Resources Development Committee of the Tohono O'odham**
20 **Legislative Council has reviewed and approved the Nineteen Tribal Nations**
21 **Workforce Investment Area Business Plan Appendix 6-Chief Local Elected**
22 **Official Agreement and Appendix 7-Chief Local Elected Official and Local Board**
23 **Partnership Agreement.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
25 **approves the Nineteen Tribal Nations Workforce Investment Area Business Plan**
26 **Appendix 6-Chief Local Elected Official Agreement and Appendix 7-Chief Local**
27 **Elected Official and Local Board Partnership Agreement, substantially in the**
28 **form attached hereto; provided that appointments to the Nineteen Tribal**
29 **Nations Workforce Investment Board shall be made by Legislative Council**
30 **resolution.**

31 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
32 **Chairman of the Tohono O'odham Nation to execute the Nineteen Tribal Nations**
