13		making the motion and second, action number, and the vote count."; and
14	WHEREAS,	the Legislative Secretary has presented a draft of the summarized minutes of the
15		November 22, 2017 emergency session for review and approval by the Legislative
16		Council; and
17	WHEREAS,	the Legislative Council has reviewed the minutes and made necessary
18		corrections.
19	NOW, THERE	FORE, BE IT ORDERED that the Tohono O'odham Legislative Council approves the
20		November 22, 2017 emergency session minutes.
