

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services BIA Adult Care
Budget Amendment No. 1)**

RESOLUTION NO. 18-184

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Health and Human Services BIA Adult Care Program**
8 **Budget in the amount of \$191,038.00 was approved by Resolution No. 17-438; and**

9 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
10 **review and approval its FY 2018 BIA Adult Care Program Budget Amendment No.**
11 **1, which is incorporated by this reference and which will increase operational**
12 **line items and decrease personnel line items and indirect costs; and**

13 **WHEREAS, the FY 2018 Department of Health and Human Services BIA Adult Care Program**
14 **Budget Amendment No. 1 will decrease the Department of Health and Human**
15 **Services FY 2018 BIA Adult Care Program Budget by \$14,257.00 from \$191,038.00**
16 **to \$176,781.00; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2018 Department of Health and Human Services BIA Adult Care**
19 **Program Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2018 Department of Health and Human Services BIA Adult Care Program**
22 **Budget Amendment No. 1 effective October 1, 2017 which includes a decrease of**
23 **\$14,257.00 from \$191,038.00 to \$176,781.00 that shall be funded by the Nation's**
24 **general fund pending reimbursement from BIA agency.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2018 Department of Health and Human Services BIA Adult Care**
28 **Program Budget as amended, provided however, that any amendments or**
29 **modifications shall be submitted for prior approval by the Tohono O'odham**
30 **Legislative Council.**
