

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2018 Department of Public Safety Fire Department Budget  
Amendment No. 1)**

**RESOLUTION NO. 18-191**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Public Safety Fire Department Budget in the amount**  
8 **of \$4,994,270.42 was approved by Resolution No. 17-437; and**

9 **WHEREAS, the Department of Public Safety Fire Department has prepared and submitted for**  
10 **review and approval its FY 2018 Budget Amendment No. 1, which is incorporated**  
11 **by this reference and which will adjust operational and/or personnel line items;**  
12 **and**

13 **WHEREAS, the FY 2018 Department of Public Safety Fire Department Budget Amendment No.**  
14 **1 does not change the original budget amount of \$4,994,270.42; and**

15 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**  
16 **2018 Department of Public Safety Fire Department Budget Amendment No. 1 and**  
17 **recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2018 Department of Public Safety Fire Department Budget Amendment No. 1,**  
20 **which does not change the original budget amount of \$4,994,270.42 that shall be**  
21 **funded by the Nation's general fund.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Nation chairperson or any designated official is authorized to administer and**  
24 **expend the FY 2018 Department of Public Safety Fire Department Budget as**  
25 **amended, provided that any amendments or modifications shall be submitted**  
26 **for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
28 **day of JUNE, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
