

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2018 Hewel Ni'ok KWAK-LP Capital Projects Budget Amendment No. 1)**

**RESOLUTION NO. 18-262**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Hewel Ni'ok KWAK-LP Capital Projects Budget in the amount of**  
8 **\$42,695.92 was approved by Resolution No. 18-118; and**

9 **WHEREAS, Hewel Ni'ok has prepared and submitted for review and approval its FY 2018**  
10 **KWAK-LP Capital Projects Budget Amendment No. 1, which is incorporated by**  
11 **this reference and which will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2018 Hewel Ni'ok KWAK-LP Capital Projects Budget Amendment No. 1 will**  
13 **not change the original budget amount of \$42,695.92; and**

14 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have reviewed**  
15 **the FY 2018 Hewel Ni'ok KWAK-LP Capital Projects Budget Amendment No. 1 and**  
16 **recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2018 Hewel Ni'ok KWAK-LP Capital Projects Budget Amendment No. 1 effective**  
19 **October 1, 2017, which does not change the original budget amount of \$42,695.92.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
21 **Nation chairperson or any designated official is authorized to administer and**  
22 **expend the FY 2018 Hewel Ni'ok KWAK-LP Capital Projects Budget as amended,**  
23 **provided that any amendments or modifications shall be submitted for prior**  
24 **approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup>**  
26 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat.984).**
