

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Natural Resources Cultural Affairs Tribal
Historic Preservation Office Budget Amendment No. 1)**

RESOLUTION NO. 18-274

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Articles VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Natural Resources Cultural Affairs Tribal Historic**
8 **Preservation Office Budget in the amount of \$83,874.00 was approved by**
9 **Resolution No. 17-477; and**

10 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
11 **approval its FY 2018 Cultural Affairs Tribal Historic Preservation Office Budget**
12 **Amendment No. 1, which is incorporated by this reference and which will adjust**
13 **operational and/or personnel line items; and**

14 **WHEREAS, the FY 2018 Department of Natural Resources Cultural Affairs Tribal Historic**
15 **Preservation Office Budget Amendment No. 1 will not change the original budget**
16 **amount of \$83,874.00; and**

17 **WHEREAS, the Cultural Preservation and the Budget and Finance Committees have reviewed**
18 **the FY 2018 Department of Natural Resources Cultural Affairs Tribal Historic**
19 **Preservation Office Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2018 Department of Natural Resources Cultural Affairs Tribal Historic**
22 **Preservation Office Budget Amendment No. 1, effective October 1, 2017, which**
23 **will not change the original budget amount of \$83,874.00.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2018 Department of Natural Resources Cultural Affairs Tribal**
27 **Historic Preservation Office Budget as amended, provided however, that any**
28 **amendments or modifications shall be submitted for prior approval by the**
29 **Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
31 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (d)(3) of the Constitution of the Tohono O'odham Nation, adopted**
34 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
35 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
36 **Act of June 18, 1934 (48 Stat.984).**
