

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Planning Department Realty Program Budget)**

RESOLUTION NO. 18-305

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Planning and Economic Development Department has prepared and**
8 **submitted for review and approval its FY 2019 Realty Program Budget, which is**
9 **incorporated by this reference, in the amount of \$330,000.00 to be funded from**
10 **the Nation's Land Acquisition fund; and**


11 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
12 **have reviewed the FY 2019 Planning Department Realty Program Budget and**
13 **recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2019 Planning Department Realty Program Budget effective October 1, 2018 in**
16 **the amount of \$330,000.00, which shall be funded by the Nation's Land Acquisition**
17 **fund.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
19 **Nation chairperson or any designated official is authorized to administer and**
20 **expend the FY 2019 Planning Department Realty Program Budget, provided that**
21 **any amendments or modifications shall be submitted for prior approval by the**
22 **Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
24 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 2,557.4 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and 527.2[08] ABSENT, pursuant to the powers vested in the Council**
26 **by Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted**
27 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
29 **Act of June 18, 1934 (48 Stat.984).**


