

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Planning and Economic Development Department Roads
Program Cowlic Road Project PIR 31 Budget)**

RESOLUTION NO. 18-307

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Planning and Economic Development Department has prepared and
8 submitted for review and approval its FY 2019 Roads Program Cowlic Road
9 Project PIR 31 Budget, which is incorporated by this reference, in the amount of
10 \$622,162.63 to be funded from the Bureau of Indian Affairs; and

11 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
12 have reviewed the FY 2019 Planning and Economic Development Department
13 Roads Program Cowlic Road Project PIR 31 Budget and recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2019 Planning and Economic Development Department Roads Program
16 Cowlic Road Project PIR 31 Budget effective October 1, 2018 in the amount of
17 \$622,162.63, which shall be funded by the Bureau of Indian Affairs.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2019 Planning and Economic Development Department Roads
21 Program Cowlic Road Project PIR 31 Budget, provided that any amendments or
22 modifications shall be submitted for prior approval by the Tohono O'odham
23 Legislative Council.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
25 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
28 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat.984).**
