

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2018 Department of Health and Human Services Senior Services
Division Elder Wellness Budget Amendment No. 1)**

RESOLUTION NO. 18-314

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2018 Department of Health and Human Services Senior Services Division**
8 **Elder Wellness Budget in the amount of \$110,550.00 was approved by Resolution**
9 **No. 17-437; and**

10 **WHEREAS, the Department of Health and Human Services Senior Services Division has**
11 **prepared and submitted for review and approval its FY 2018 Elder Wellness**
12 **Budget Amendment No. 1, which is incorporated by this reference and which will**
13 **adjust operational and/or personnel line items; and**

14 **WHEREAS, the FY 2018 Department of Health and Human Services Senior Services Division**
15 **Elder Wellness Amendment No. 1 will increase the FY 2018 Department of Health**
16 **and Human Services Senior Services Division Elder Wellness Budget by**
17 **\$10,400.00 from \$110,550.00 to \$120,950.00; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2018 Department of Health and Human Services Senior Services**
20 **Division Elder Wellness Budget Amendment No. 1 and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2018 Department of Health and Human Services Senior Services Division Elder**
23 **Wellness Budget Amendment No. 1 effective October 1, 2017, which includes a**
24 **\$10,400.00 increase from \$110,550.00 to \$120,950.00 that shall be funded from the**
25 **Elder Conference registration fees revenue.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2018 Department of Health and Human Services Senior Services**
29 **Division Elder Wellness Budget as amended, provided however, that any**
30 **amendments or modifications shall be submitted for prior approval by the**
31 **Tohono O'odham Legislative Council.**


