

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Behavioral Health Tas Tonlik Ki Program/SMI Program Revenue Budget)**

RESOLUTION NO. 18-327

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services Division of Behavioral Health has**
8 **prepared and submitted for review and approval its FY 2019 Division of**
9 **Behavioral Health Tas Tonlik Ki Program/SMI Program Revenue Budget, which is**
10 **incorporated by this reference, in the amount of \$1,066,353.00 to be funded from**
11 **program revenues; and**

12 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
13 **reviewed the FY 2019 Department of Health and Human Services Division of**
14 **Behavioral Health Tas Tonlik Ki Program/SMI Program Revenue Budget and**
15 **recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 Department of Health and Human Services Division of Behavioral Health**
18 **Tas Tonlik Ki Program/SMI Program Revenue Budget, effective October 1, 2018 in**
19 **the amount of \$1,066,353.00, which shall be funded by program revenues.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2019 Department of Health and Human Services Division of**
23 **Behavioral Health Tas Tonlik Ki Program/SMI Program Revenue Budget,**
24 **provided that any amendments or modifications shall be submitted for prior**
25 **approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15TH**
27 **day of AUGUST, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**




