

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Enrollment Applications for Membership in the Tohono O'odham  
Nation for Applicants Previously Recommended for Approval)**

**RESOLUTION NO. 18-365**

1   **WHEREAS,**   Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the  
2                   Tohono O'odham Legislative Council with the power to "enact laws and  
3                   ordinances governing the enrollment and adoption of members and the  
4                   relinquishment and loss of membership"; and  
5   **WHEREAS,**   enrollment applications originally received on October 22, 1974, were previously  
6                   recommended for approval by the Enrollment Committee on September 3, 1982,  
7                   and given enrollment numbers; and  
8   **WHEREAS,**   on June 29, 2016, the Enrollment Office discovered that although the individuals  
9                   were not listed on any resolution approving membership, the individuals had  
10                  been treated as if approved for membership by Resolution No. 115-82 effective  
11                  September 10, 1982, in which several of their family members were approved; and  
12   **WHEREAS,**   while all available documents and records show that the Enrollment Committee  
13                  had reviewed and recommended approval of the enrollment applications for the  
14                  individuals identified in the September 2018 Membership Applications List prior  
15                  to approval by Council of Resolution No. 115-82, for unknown reasons, the names  
16                  of the individuals listed on the September 2018 Membership Applications List  
17                  were not part of the list of names approved by Resolution No. 115-82; and  
18   **WHEREAS,**   all the individuals on the September 2018 Membership Applications List, which is  
19                  incorporated by this reference, meet the membership requirements of Article II  
20                  of the Constitution of the Tohono O'odham Nation and have had enrollment  
21                  numbers since September 10, 1982; and  
22   **WHEREAS,**   pursuant to Article VIII, Section 1 (C)(1) and (2) of the Enrollment Ordinance:  
23                                The final determination to approve or reject an application for membership  
24                                or adoption shall be recorded in a Council resolution. Each determination  
25                                shall set forth the following findings of fact:  
26                                (1) If an application for adoption is approved, the applicant's date of birth,  
27                                the degree of Papago-Tohono O'odham Indian blood ascribed to the  
28                                applicant, and the Enrollment Committee's recommendation that the  
29                                application be approved or rejected;  
30                                (2) If an application for membership is approved, the applicant's date of  
31                                birth, the membership requirement which Council determined that the  
32                                applicant established, and the Enrollment Committee's recommendation  
33                                that the application be approved or rejected; and

1 **WHEREAS, the Rules Committee reviewed the membership applications on the September**  
2 **2018 Membership Applications List and recommend approval with an effective**  
3 **date of September 10, 1982 to align with the effective date of Resolution No. 115-**  
4 **82.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed**  
6 **the Enrollment Committee's recommendation and approves the applications for**  
7 **enrollment that are identified in the September 2018 Membership Applications**  
8 **List, effective September 10, 1982, which includes the name, date of birth,**  
9 **enrollment number, and membership requirement established.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>**  
11 **day of SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,557.4 FOR;**  
12 **527.2 AGAINST; [01] NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council**  
13 **by Article II, Section 1(a) or (b) and Section 2 and Article VI, Section 1(h) of the Constitution of the**  
14 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**  
15 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
16 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
