

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Legislative Order No. 18-368 "Setting September 21, 2018 Special
Session to Review and Consider District Budgets")

LEGISLATIVE ORDER NO. 18-370

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**
3 **committees, boards and special committees." (Constitution of the Tohono**
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**
6 **Council with the authority to "by majority vote, call for a special session"**
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**
8 **1.D.1.); and**

9 **WHEREAS, Legislative Order No 18-368 set a special session on September 21, 2018 with roll**
10 **call beginning at 1:00 p.m to review and consider district budgets, but the time**
11 **for roll call needs to be changed.**

12 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it amends**
13 **Legislative Order No. 18-368 to set a special session on September 21, 2018 with**
14 **roll call beginning at 9:00 a.m to review and consider district budgets.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13TH day of**
16 **SEPTEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
18 **Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
21 **June 18, 1934 (48 Stat.984).**
