

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Certification of and Distribution to Tohono O'odham Nation Eligible**  
**Adult Members for the Third Per Capita Distribution for November 2018)**

**RESOLUTION NO. 18-434**

1 **WHEREAS,** on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the  
2 "O'odham Voice on Use of Gaming Revenues" (the "Initiative"), which authorizes  
3 per capita payments to the Nation's members provided that sufficient gaming  
4 revenues are available; and

5 **WHEREAS,** the Ordinance for the Regulation of Gaming Activities Within the Tohono  
6 O'odham Nation (the "Gaming Ordinance") was subsequently amended to  
7 authorize per capita distribution payments in accordance with the Initiative  
8 (Legislative Council Resolution No. 97-303); and

9 **WHEREAS,** the Legislative Council did adopt the Third Revenue Allocation Plan pursuant to  
10 Legislative Council Resolution No. 06-307; and

11 **WHEREAS,** on July 28, 2006, the Secretary of the Department of Interior approved the Third  
12 Revenue Allocation Plan; and

13 **WHEREAS,** the Tohono O'odham Nation Department of Membership Services submitted to  
14 the Tohono O'odham Legislative Council the Master List for Eligible Adult Tohono  
15 O'odham Members for the Third Per Capita Distribution ("Master List") for review  
16 and approval; and

17 **WHEREAS,** Legislative Council approved the Master List with the initial number of 17,669  
18 verified adult members (Resolution Number 06-624); and

19 **WHEREAS,** the disbursement of funds to each eligible adult member is contingent upon  
20 verification of a member and certification by the Tohono O'odham Legislative  
21 Council; and

22 **WHEREAS,** the Tohono O'odham Department of Membership Services has submitted a  
23 certification list of 2 verified adult members who are listed on the previously  
24 approved Master List and are eligible to receive the third per capita payment.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby:

- 26 1. Approves the verification and certification of 2 adult members listed on the  
27 attached November 2018 Certification Listing of Adult Members for the Third  
28 Per Capita Distribution.
- 29 2. Approves the distribution of \$2,000, less any applicable taxes required by  
30 federal law, to each adult member listed.
- 31 3. Authorizes the Chairperson of the Nation or a designated official to execute  
32 such other documents as may be necessary to implement this resolution.



3 **verification of membership by the Tohono O'odham Department of Membership**  
4 **Services and certification by the Tohono O'odham Legislative Council.**

5 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
6 **day of NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**  
7 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
8 **Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
9 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
10 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
11 **18, 1934 (48 Stat.984).**






