

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recognition of Relinquishment from membership in the Tohono O'odham
Nation for the month of December 2018)

RESOLUTION NO. 18-455

1 **WHEREAS,** Article VI, Section 1(h) of the Constitution of the Tohono O'odham Nation vests the
2 Tohono O'odham Legislative Council with the power to "enact laws and
3 ordinances governing the enrollment and adoption of members and the
4 relinquishment and loss of membership"; and

5 **WHEREAS,** in accordance with the Tohono O'odham Nation's Enrollment Ordinance,
6 Ordinance No. 05-81 as amended the Enrollment Committee has received written
7 statements from 01 tribal member who have expressed their intent to relinquish
8 their membership with the Tohono O'odham Nation and the member is identified
9 in the December 2018 Relinquishment List, which is incorporated by this
10 reference; and

11 **WHEREAS,** pursuant to Article IX Section 1 of the Enrollment Ordinance,

12 A member of the Nation may relinquish his membership in the Nation by
13 submitting a written statement clearly expressing an intent to relinquish his
14 membership to the Council, a copy of which must be served on the
15 committee. The written statement must be signed by the person wishing to
16 relinquish his membership or, if a minor or incompetent, by the parent(s),
17 guardian or other person legally authorized to act on his behalf.
18 Relinquishment does not require the approval of the Council, but is effective
19 upon receipt of the statement by the Council and cannot be subsequently
20 denied. Upon recognition by the Council that the individual has renounced
21 his membership, his name shall be deleted from the membership roll.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council hereby
23 recognizes that the individual identified in the December 2018 Relinquishment
24 List have relinquished their membership in the Tohono O'odham Nation and
25 orders the removal of their name from the Nation's membership roll.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03RD**
27 **day of December, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR;**
28 **~~-0-~~ AGAINST; ~~-0-~~ NOT VOTING; and 232.3[05] ABSENT, pursuant to the powers vested in the**
29 **Council by Article VI, Section 1 (h) of the Constitution of the Tohono O'odham Nation, adopted**
30 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
31 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
32 **Act of June 18, 1934 (48 Stat.984).**
