

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending Enrollment Resolution Nos. 15-80, 06-81, 49-81, 127-83, 129-83, 40-84,  
202-85, 95-003, 95-192, 138-87, 195-87, 97-256, 04-659, 12-001, and 18-098 to  
Reflect Legal Name Changes of Enrolled Members)**

**RESOLUTION NO. 18-456**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to enact laws**  
2 **and ordinances governing the enrollment and adoption of members (Article II,**  
3 **Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono**  
4 **O'odham Nation); and**

5 **WHEREAS, Articles VI and VII of the Nation's Enrollment Ordinance provide that the**  
6 **Enrollment Committee is responsible for reviewing enrollment applications and**  
7 **making recommendations to the Legislative Council regarding the eligibility of**  
8 **applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and**

9 **WHEREAS, Article VIII of the Nation's Enrollment Ordinance provides that the Tohono**  
10 **O'odham Legislative Council shall determine whether an application is approved**  
11 **for membership and its determination, along with the resolution number and**  
12 **date of enactment, shall be provided to the applicant; and**

13 **WHEREAS, the Enrollment Program has received the official documents showing the legal**  
14 **name changes of enrolled members due to a variety of reasons, such as marriage,**  
15 **divorce, or legal adoption; and**

16 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 15-80, 06-**  
17 **81, 49-81, 127-83, 129-83, 40-84, 202-85, 95-003, 95-192, 138-87, 195-87, 97-256, 04-**  
18 **659, 12-001, and 18-098 be amended to reflect the amended names for the**  
19 **members identified in the December 2018 Amended Enrollment Resolution**  
20 **Summary, which is incorporated by this reference.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**  
22 **Nos. 15-80, 06-81, 49-81, 127-83, 129-83, 40-84, 202-85, 95-003, 95-192, 138-87, 195-**  
23 **87, 97-256, 04-659, 12-001, and 18-098 are amended upon the effective date of**  
24 **those resolutions to reflect the legal name changes for the members identified in**  
25 **the December 2018 Amended Enrollment Resolution Summary.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
27 **day of December, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR;**  
28 **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 232.3[05] ABSENT, pursuant to the powers vested in the**  
29 **Council by Article II, Sections 1 and 2 and Article VI, Section1 (h) of the Constitution of the**  
30 **Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and**  
31 **approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
32 **1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**


