**Names of Enrolled Members and/or Enrollment Numbers)**

**RESOLUTION NO. 18-457**

1   **WHEREAS,**    the Tohono O'odham Legislative Council is vested with the power to enact laws  
2                    and ordinances governing the enrollment and adoption of members (Article II,  
3                    Sections 1 and 2 and Article VI, Section 1 (h) of the Constitution of the Tohono  
4                    O'odham Nation); and

5   **WHEREAS,**    Articles VI and VII of the Nation's Enrollment Ordinance provide that the  
6                    Enrollment Committee is responsible for reviewing enrollment applications and  
7                    making recommendations to the Legislative Council regarding the eligibility of  
8                    applicants (Ordinance No. 05-81, as amended; 14 T.O.C. Chapter 1); and

9   **WHEREAS,**    Article VIII of the Nation's Enrollment Ordinance provides that the Tohono  
10                   O'odham Legislative Council shall determine whether an application is approved  
11                   for membership and its determination, along with the resolution number and  
12                   date of enactment, shall be provided to the applicant; and

13   **WHEREAS,**    the Enrollment Program has determined that a number of resolutions approving  
14                   membership and adoption applications misspelled or incorrectly listed the  
15                   names of members and/or incorrectly listed enrollment numbers; and

16   **WHEREAS,**    the Enrollment Program therefore recommends that Resolution Nos. 83-83,426-  
17                   86, 99-633, 01-183, 01-543, 02-003, 02-180, 03-301, 04-508, 05-301, 08-606, 18-350,  
18                   18-406 and 18-408 be amended to reflect the correct name and/or enrollment  
19                   number for the members identified in the December 2018 Corrected Enrollment  
20                   Resolution Summary, which is incorporated by this reference.

21   **NOW, THEREFORE, BE IT RESOLVED** by the Tohono O'odham Legislative Council that Resolution  
22                   Nos. 83-83, 426-86, 99-633, 01-183, 01-543, 02-003, 02-180, 03-301, 04-508, 05-301,  
23                   08-606, 18-350, 18-406 and 18-408 are amended upon the effective date of those  
24                   resolutions to reflect the correct name and/or enrollment number for the  
25                   members identified in the December 2018 Corrected Enrollment Resolution  
26                   Summary.

27   **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
28   **day of December, 2018 at a meeting at which a quorum was present with a vote of 2,852.3 FOR;**  
29   **~~0~~ AGAINST; ~~0~~ NOT VOTING; and 232.3[05] ABSENT, pursuant to the powers vested in the**  
30   **Council by Article II, Section 1 and 2 and Article VI, Section 1(h) of the Constitution of the Tohono**  
31   **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by**  
32   **the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant**  
33   **to Section 16 of the Act of June 18, 1934 (48 Stat.984).**






