9	WHEREAS,	Article VIII of the Nation's Enrollment Ordinance provides that the Tohono
10		O'odham Legislative Council shall determine whether an application is approved
11		for membership and its determination, along with the resolution number and
12		date of enactment, shall be provided to the applicant; and
13	WHEREAS,	the Enrollment Program has determined that a number of resolutions approving
14		membership and adoption applications misspelled or incorrectly listed the
15		names of members and/or incorrectly listed enrollment numbers; and
16	WHEREAS,	the Enrollment Program therefore recommends that Resolution Nos. 83-83,426-
17		86, 99-633, 01-183, 01-543, 02-003, 02-180, 03-301, 04-508, 05-301, 08-606, 18-350,
18		18-406 and 18-408 be amended to reflect the correct name and/or enrollment
19		number for the members identified in the December 2018 Corrected Enrollment
20		Resolution Summary, which is incorporated by this reference.
