11		a contract between the Tohono O'odham Nation and the BOR; and
12	WHEREAS,	the FY 2019 BOR SAWRSA Budget provides for a Water Management Plan and
13		Groundwater Monitoring Program for the Schuk Toak District under the SAWRSA
14		amendments; and
15	WHEREAS,	Water Resources and Budget and Finance Committees have reviewed the FY 2019
16		Water Resources Department, BOR SAWRSA Budget and recommend its approval.
17	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2019 Water Resources Department BOR SAWRSA Budget in the amount of
19		\$235,458.43 which shall be funded by a contract between the Tohono O'odham
20		Nation and the BOR.
