

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Special Needs
Program First Things First Child Support Budget Amendment No. 1)**

RESOLUTION NO. 18-465

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Health and Human Services Special Needs Program
8 First Things First Child Support Budget in the amount of \$152,208.00 was
9 approved by Resolution No. 18-186; and

10 **WHEREAS,** the Department of Health and Human Services Special Needs Program has
11 prepared and submitted for review and approval its FY 2019 First Things First
12 Child Support Budget Amendment No. 1, which is incorporated by this reference,
13 and will adjust personnel and/or operational line items with no change to total
14 budget amount of \$152,208.00; and

15 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
16 reviewed the FY 2019 Department of Health and Human Services Special Needs
17 Program First Things First Child Support Budget Amendment No. 1 and
18 recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2019 Department of Health and Human Services Special Needs Program First
21 Things First Child Support Budget Amendment No. 1, effective July 1, 2018 in the
22 amount of \$152,208.00, which shall be funded by the Nation's general fund
23 pending reimbursement from grantor, the Arizona Early Childhood
24 Development and Health Board.

25 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
26 Nation chairperson or any designated official is authorized to administer and
27 expend the FY 2019 Department of Health and Human Services Special Needs
28 Program First Things First Child Support Budget as amended, provided however,
29 that any amendments or modifications shall be submitted for prior approval by
30 the Tohono O'odham Legislative Council.
