

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2019 U.S. Department of Justice, Office of Justice Programs**  
**Award No. 2017-AW-BX-0049, Enhancement of the Tohono O'odham**  
**Nation Police Department's SORNA Program Budget)**

**RESOLUTION NO. 18-471**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Public Safety, Police Department applied for and was  
8 awarded the United States (U.S.) Department of Justice (DOJ), Office of Justice  
9 Programs (OJP) Enhancement of the Tohono O'odham Nation Police  
10 Department's SORNA Program, Award No. 2017-AW-BX-0049 in the amount of  
11 \$298,077.00 which was accepted and approved by Resolution No. 18-090; and

12 **WHEREAS,** this grant is effective October 1, 2017 thru September 30, 2019; and

13 **WHEREAS,** this grant allows for Indirect Cost Charges; and

14 **WHEREAS,** the Department of Public Safety Police Department has prepared and submitted  
15 for review and approval its FY 2019 Budget which is incorporated by this  
16 reference and which shall be funded by the Nation's General Fund pending  
17 reimbursement by the grantor; and

18 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
19 2019 Department of Public Safety Police Department U.S. DOJ, OJP Enhancement  
20 of the Tohono O'odham Nation Police Department's SORNA Program budget and  
21 recommend its approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
23 FY 2019 Department of Public Safety Police Department U.S. DOJ, OJP  
24 Enhancement of the Tohono O'odham Nation Police Department's SORNA  
25 Program effective October 1, 2018, in the amount of \$164,020.85 that shall be  
26 funded by the Nation's general fund pending reimbursement from the Grantor.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
28 Nation chairperson or any designated official is authorized to administer and  
29 expend the FY 2019 U.S., DOJ, OJP Enhancement of the Tohono O'odham Nation  
30 Police Department's SORNA Program budget, provided however, that any  
31 amendments or modifications shall be submitted for prior approval by the  
32 Tohono O'odham Legislative Council.
