10		Gaming Office Budget Amendment No. 1, which is incorporated by this reference,
11		and which creates the capital equipment line item; and
12	WHEREAS,	the FY 2019 Executive Branch Gaming Office Budget Amendment No. 1 will
13		increase the FY 2019 Gaming Office Budget by \$30,000.00 from \$9,684,355.71 to
14		\$9,714,355.71; and
15	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2019 Executive Branch
16		Gaming Office Budget Amendment No. 1 and recommends its approval.
17	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
18		FY 2019 Executive Branch Gaming Office Budget Amendment No. 1 effective
19		October 1, 2018, which includes \$30,000.00 increase from \$9,684,355.71 to
20		\$9,714,355.71 that shall be funded by the Nation's general fund and which creates
21		a new Capital Equipment Line item.
