

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Executive Branch Gaming Office Budget Amendment No. 1)**

RESOLUTION NO. 18-472

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Executive Gaming Office Budget in the amount of \$9,684,355.71 was**
8 **approved by Resolution 18-339; and**

9 **WHEREAS, Executive Branch has prepared and submitted for review and approval its FY 2019**
10 **Gaming Office Budget Amendment No. 1, which is incorporated by this reference,**
11 **and which creates the capital equipment line item; and**

12 **WHEREAS, the FY 2019 Executive Branch Gaming Office Budget Amendment No. 1 will**
13 **increase the FY 2019 Gaming Office Budget by \$30,000.00 from \$9,684,355.71 to**
14 **\$9,714,355.71; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Executive Branch**
16 **Gaming Office Budget Amendment No. 1 and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2019 Executive Branch Gaming Office Budget Amendment No. 1 effective**
19 **October 1, 2018, which includes \$30,000.00 increase from \$9,684,355.71 to**
20 **\$9,714,355.71 that shall be funded by the Nation's general fund and which creates**
21 **a new Capital Equipment Line item.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2019 Executive Gaming Office Budget as amended, provided that**
25 **any amendments shall be submitted for prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
28 **day of DECEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
