

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Department of Health and Human Services Division of Senior**  
**Services Title VI Budget Amendments No. 1)**

**RESOLUTION NO. 18-483**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Health and Human Services Division of Senior Services  
8 Title VI Part C Budget in the amount of \$55,280.00 and Title VI Part A Budget in the  
9 amount of \$180,720.00 were approved by Resolution No. 18-094; and

10 **WHEREAS,** the Department of Health and Human Services ("DHHS") has prepared and  
11 submitted for review and approval its FY 2019 Division of Senior Services Title VI  
12 Budget Amendments No. 1, which are incorporated by this reference and which  
13 will adjust operational and/or personnel line items; and

14 **WHEREAS,** the FY 2019 DHHS Division of Senior Services Title VI Part C Budget Amendment  
15 No. 1 will increase the FY 2019 DHHS Senior Services Title VI Part C Budget by  
16 \$24,673.41 from \$55,280.00 to \$79,953.41; and

17 **WHEREAS,** the FY 2019 DHHS Division of Senior Services Title VI Part A Budget Amendment  
18 No. 1 will increase the FY 2019 DHHS Senior Services Title VI Part A Budget by  
19 \$81,873.91 from \$180,720.00 to \$262,593.91; and

20 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
21 reviewed the FY 2019 DHHS Division of Senior Services Title VI Budget  
22 Amendments No. 1 and recommend their approval.

23 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
24 FY 2019 Department of Health and Human Services Division of Senior Services  
25 Title VI Part C Budget Amendment No. 1 effective April 1, 2018, which includes a  
26 \$24,673.41 increase, of which \$11,843.41 is funded by carryover funds, from  
27 \$55,280.00 to \$79,953.41 and Title VI Part A Budget Amendment No. 1 effective  
28 April 1, 2018, which includes a \$81,873.91 increase from \$180,720.00 to  
29 \$262,593.91, of which \$72,213.91 is funded by carryover funds and \$9,660.00 is  
30 funded by the Nation's general fund pending reimbursement from the grantor,  
31 Title VI Older Americans Act of 1978.

6 **for prior approval.**


7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**

10 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
11 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
13 **18, 1934 (48 Stat.984).**


