1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the authority to "promote, protect and provide for public health, peace, morals,
3		education and general welfare of the Tohono O'odham Nation and its members"
4		and to "consult, negotiate and conclude agreements and contracts on behalf of
5		the Tohono O'odham Nation with Federal, State and local governments and other
6		Indian tribes or their departments" (Constitution, Article VI, Section 1(c)(2)
7		and Section 1(f)); and
8	WHEREAS,	the Tohono O'odham Legislative Council is also authorized "to manage any funds
9		within the exclusive control of the Tohono O'odham Nation \ldots and to appropriate
10		these funds for the benefit of the nation and its members" provided that "[a]ll
11		expenditures of these funds shall be pursuant to appropriations or budgets"
12		authorized by resolution or ordinance (Constitution of the Tohono O'odham
13		Nation, Article VI, section 1(d)(2)); and
14	WHEREAS,	a previous Intergovernmental Agreement ("IGA") was established between the
15		Tohono O'odham Nation and the Arizona Department of Economic Security to
16	6	provide the Tohono O'odham Nation with funds for specific Workforce
17		Innovation and Opportunity Act ("WIOA") employment and training programs
18		operated by the Education Department's One Stop Division; and
19	WHEREAS,	the Tohono O'odham Nation has negotiated a new Intergovernmental Agreement
20		with the Arizona Department of Economic Security for WIOA funds for a five-year
21		term from July 1, 2018 to June 30, 2023; and
22	WHEREAS,	the IGA that was approved by Resolution No. 15-441, is valid from July 1, 2015 to
23		June 30, 2020 with funding to FY 2018, which will run concurrently with this
24		presented IGA to be valid from July 1, 2018 to June 30, 2023 with funding starting
25		from FY 2019; and
26	WHEREAS,	the FY 2018 Department of Education One Stop Division PY18/FY19 Budgets in the
27		amount of \$376,542.99 was approved by Resolution No. 18-230 and all subsequent
28		budgets for each fiscal year, for the duration of the IGA, will be added by
29		additional amendments to the IGA; and
30	WHEREAS,	the Human Resources Development Committee has reviewed the Arizona
31		Department of Economic Security Workforce Innovation and Opportunity Act,
32		Title 1B Intergovernmental Agreement and recommends its approval.
