

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Arizona Department of Economic Security for the Planned Social
Services Block Grant Title XX FY 2019 Intergovernmental Agreement)**

RESOLUTION NO. 18-486

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the authority to "consult, negotiate and conclude agreements and contracts on**
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**
4 **and other Indian tribes. . ." and "to promote, protect and provide for public**
5 **health, peace, morals, education and general welfare of the Tohono O'odham**
6 **Nation and its members" (Constitution, Article VI, Section 1(f) and Section 1(c)(2));**
7 **and**

8 **WHEREAS, the Department of Education Child Care Services provides services to improve**
9 **the availability, affordability, and quality of child care through funding provided**
10 **by the Arizona Department of Economic Security ("AZDES") Planned Social**
11 **Services Block Grant Title XX Program; and**

12 **WHEREAS, the Tohono O'odham Nation has negotiated with the Arizona Department of**
13 **Economic Security for an Arizona Department of Economic Security Planned**
14 **Social Services Block Grant Title XX FY 2019 Intergovernmental Agreement with**
15 **a reimbursement ceiling of \$101,693.00 for the period of July 1, 2018 to June 30,**
16 **2019; and**

17 **WHEREAS, the FY 2019 Department of Education Child Care Services Title XX Budget in the**
18 **amount of \$101,693.00 was approved by Resolution No. 18-231; and**

19 **WHEREAS, the Human Resources Development Committee has reviewed the Arizona**
20 **Department of Economic Security Planned Social Services Block Grant Title XX**
21 **FY 2019 Intergovernmental Agreement and recommends its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **Arizona Department of Economic Security Planned Social Services Block Grant**
24 **Title XX FY 2019 Intergovernmental Agreement for July 1, 2018 to June 30, 2019,**
25 **substantially in the form attached.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to execute the**
28 **Intergovernmental Agreement, provided however that any amendments shall be**
29 **submitted for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
31 **day of DECEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
32 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(c)(2) and (f) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
