1	WHEREAS,	the Constitution of the Tohono O'odham Nation vests the Legislative Council with
2		the power "to consult, negotiate and conclude agreements and contracts on
3		behalf of the Tohono O'odham Nation with Federal, State and local governments
4	•	and other Indian tribes or their departments, agencies, or political subdivisions,
5		or with private persons or organizations on all matters within the authority of the
6		Tohono O'odham Council." (Constitution Article VI, Section 1(f)); and
7	WHEREAS,	the Tohono O'odham Legislative Council is authorized "to manage any funds
8		within the exclusive control of the Tohono O'odham Nation and to appropriate
9		these funds for the benefit of the nation and its members" provided that "[a]ll
10		expenditures of these funds shall be pursuant to appropriations or budgets"
11		authorized by resolution or ordinance (Constitution of the Tohono O'odham
12		Nation, Article VI, Section 1(d)(2)); and
13	WHEREAS,	the Low Income Home Energy Assistance Program ("LIHEAP") is a federally
14		funded program, administered through the Arizona Department of Economic
15		Security ("ADES"), that helps low-income households pay their heating/cooling
16		bills, minimize crises, and make energy costs more affordable; and
17	WHEREAS,	the LIHEAP Intergovernmental Agreement ("IGA") between the Nation and ADES
18		was approved by Resolution No. 16-212 for the period of July 1, 2015 through June
19		30, 2020 which will provide funding to the Nation for the LIHEAP on an annual
20		basis in the amount of \$62,572.00; and
21	WHEREAS,	the ADES has submitted LIHEAP IGA Amendment No. 4 to revise the Case
22		Management Service Budget by \$62,428.00 from \$62,572.00 to \$125,000.00 for the
23		period of July 1, 2018 through June 30, 2019; and
24	WHEREAS,	the FY 2019 Department of Health and Human Services Division of Family
25		Assistance LIHEAP Budget in the amount of \$62,572.00 was approved by
26		Resolution No. 18-151; and
27	WHEREAS,	the Department of Health and Human Services Division has prepared and
