WHEREAS, The construction of the Tribal adobe units is progressing satisfactorily but the units must be completed and be ready for use by October 21 and 22, 1950, the dates set aside for the Annual Papago Indian Rodeo and Arts & Crafts Exhibit, and

WHERMAS, It has become necessary to hire additional men to complete the project,

THEREFORE, BE IT RESCLVED BY THE PAPAGO COUNCIL, That the following men be paid for work on the project at the following rates:

PROVIDED, That the above payments shall be made in accordance with the attached certified time sheets, and FURTHER PROVIDED, That additional workmen may be hired and rates of pay established for them by the Tribal Officials if the need arises, and

BE IT FURTHER RESOLVED, That Account PT-21, Tribal Adobe Units, be set up and expenditure therefrom made for labor, supplies, fixtures, equipment, and any and all other items pertaining to the construction of the Tribal Adobe Units, and

BE IT FURTHER RESOLVED, That the Superintendent of the Papago Agency be instructed to transfer \$5,500.00 from Fund PT-1, General Fund, to PT-21, Tribal Adobe Units, and

BE IT FINALLY RESOLVED, That PT-7, Miscellaneous Fund, shall be reimbursed from PT-21 for expenditures made from FT-7 on the Tribal Adobe Units.

The foregoing resolution was on September 22, 1950, duly enacted by a vote of 13 for and 0 against, by the Papago Council, pursuant to authority vested in it by Sec. 3 (a) of Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934. (48 Stat. 984). Said resolution is effective a of the date of its approval by the Superintendent of the Papago Agency and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V of the Constitution and By-Laws of the Papago Tribe.
