

**RESOLUTION**  
**OF**  
**THE PAPAGO COUNCIL**

Res. No. 619

WHEREAS, Under the present system the Papago Law and Order operations are entirely dependent upon the income of the Papago Tribal Court which income has been sufficient to support the operations of the Papago Tribal Court, but which income has been variable in amounts and irregular, whereas the expenditures are regular and fixed, and

WHEREAS, It is the feeling of the Papago Council that all operations of the Papago Tribal Court should be revised so as to more nearly conform to the existing procedure of budgeting for the ordinary expenses of the Papago Tribal Government.

THEREFORE BE IT RESOLVED BY THE PAPAGO COUNCIL, That Account PT-8A, Papago Tribal Court operations, be established and that the sum of \$7,850.00 be appropriated to the Account PT-8A from the following Accounts in the following manner; \$1,000.00 from Account PT-8, Papago Tribal Court Fund, to Account PT-8A and; \$6,850.00 from Account PT-1, General Fund, to Account PT-8A; as the Papago Tribal Court Budget for Fiscal Year 1953, and the Secretary and Treasurer be authorized to sign vouchers from Fund PT-8A for the amounts and purposed called for in the following budget.

BE IT FURTHER RESOLVED, That all of the receipts of the Papago Tribal Court for the Fiscal Year 1953 shall be deposited in Account PT-8, Papago Tribe, Court Fund, and

BE IT FURTHER RESOLVED, That at the end of Fiscal Year 1953 Account

PT-8, Papago Tribe, Court Fund, shall reimburse Account PT-1, General Fund, the \$7,850.00 appropriated therefrom to Account PT-8A, Papago Tribal Court Operations and any unobligated balance in Account PT-8A shall revert to PT-8, Papago Tribe, Court Fund.

The foregoing resolution was on June 27, 1952, duly enacted by the Papago Council by a vote of 13 for and 0 against, pursuant to authority vested in it by Sec. 3 (a), Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Sec. 16 of the Act of June 18, 1934, (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V of the Constitution and By-Laws of the Papago Tribe.

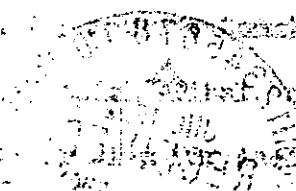
