

RESOLUTION  
OF  
THE PAPAGO COUNCIL

Res. No. 628

WHEREAS, Resolution No. 620 of the Papago Council contains certain errors and omissions,

THEREFORE BE IT RESOLVED BY THE PAPAGO COUNCIL, That Resolution No. 620 is hereby revised to read as follows:

WHEREAS, There is now \$34,865.86 outstanding in loans to the members of the Papago Tribe, many of which loans are in delinquent status, and

WHEREAS, The Papago Loan Board has recommended to the Papago Council that the loaning phase of the program be temporarily terminated pending a revision of the Loan Board's procedure in collecting loans, and

WHEREAS, It is anticipated that with a revision of the Loan Board's procedure more money can be collected on the delinquent loans so that the outstanding balance can be greatly reduced,

THEREFORE BE IT RESOLVED BY THE PAPAGO COUNCIL, That Account PT-12A, Papago Loan Board Operation, be established and the Superintendent of the Papago Agency be instructed to transfer the following amounts from the following accounts to account PT-12A, Papago Loan Board Operation: \$222.86 from Account PT-12, Papago Loan Board Expenses; \$2,474.04 from Account PT-11, Papago Loan Fund and; \$1,991.10 from Account PT-1, General Fund, for the ordinary expenses of the Papago Loan Board for the Fiscal Year 1953; and

BE IT FURTHER RESOLVED: That the Secretary and Treasurer of the Papago Council is hereby authorized to sign vouchers for the amounts and purposes called for in the following budget.

4. Loan Board Truck operations, Maintenance and Repairs-----	500.00
5. Loan Board Manager bond premium and truck insurance coverage-----	120.00

BE IT FURTHER RESOLVED, That the above appropriation be adopted as the budget of the Papago Loan Board for the Fiscal Year 1953

PROVIDED: That at the end of the Fiscal Year 1953 Account PT-1, General Fund, shall be reimbursed from Account PT-11, Papago Loan Fund, the \$1,991.10 transferred therefrom to the above budget and any unobligated balances in any of the budget items shall revert to Account PT-12, Papago Loan Board Expenses.

The foregoing Resolution was on July 11, 1952, duly enacted by a vote of 13 for and 0 against, by the Papago Council, pursuant to authority vested in it by Section 3 (a), Article V of the Constitution of the Tribe, ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Sells Agency, subject to its rescission by the Secretary of the Interior, pursuant to Section 6, Article V of the Constitution and By-Laws of the Papago Tribe.
