

RESOLUTION
OF
THE PAPAGO COUNCIL

Res. No. 630

WHEREAS, The Papago Livestock Board has submitted to the Papago Council its proposed Tribal Herd Budget for the Fiscal Year 1953 with the recommendation that it be approved, and

WHEREAS, The Livestock Board has submitted an analysis of expenditures from the Tribal Herd Budget for the Fiscal Year 1952, for comparison,

THEREFORE BE IT RESOLVED BY THE PAPAGO COUNCIL, That Account PT-9C, Papago Tribal Herd Operation, be established and that the sum of \$25,410.00 be appropriated from Account PT-9, Papago Tribal Herd, to Account PT-9C, Papago Tribal Herd Operation for the ordinary expenses of the Papago Tribal Herd for the Fiscal Year 1953, and

BE IT FURTHER RESOLVED, That the Secretary and Treasurer of the Papago Council be authorized to sign vouchers for the purposes and amounts called for below,

PROVIDED, That at the end of Fiscal Year 1953 any unobligated balances in any one of the budget items shall revert to PT-9, Papago Tribal Herd, and

PROVIDED FURTHER, That the Papago Livestock Board shall submit an analysis of the expenditures at the end of the Fiscal Year 1953 for comparison with the Fiscal Year 1954 budget.

The foregoing resolution was on July 11, 1952, duly enacted by a vote of 13 for and 0 against by the Papago Council, pursuant to authority vested in it by Section 3 (a), Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency, and is subject to the rescission by the Secretary of the Interior pursuant to Sec. 6, Article V of the Constitution and By-Laws of the Papago Tribe.
