EMMENAS, for a number of years the Vice-Chairman of the Papago Tribal Council has been a tribal employee and therefore has not received any per diem either for attending meetings of the Tribal Council or when he attended other nuthorized meetings, and

UHENEAS, the newly elected Vice-Chairman is not a tribal employee, and

WEEKLAS, the Papago Tribal Council wishes to go on record as to what per diem and travel expenses should be paid to a Vice-Chairman who does not receive salary from any other Tribal source, when he is on Tribal besiness only, in accordance with the By-Laws of the Papago Tribe, Article I, Section 2, which reads as follows:

"The Vice-Chairman of the Papago Council shall assist the Chairman when requested to do so, and in the absence of the Chairman, he shall preside and assume all the duties of the Chairman."

THE PEPONS, LET IT HE RESOLVED that whom a Vice-Chairman who receives no other salary from the Tribe, attends Tribal Council meetings, he shall receive the same per diem and mileage allowance as Councilmen, which is at present \$10.00 per Council meeting, and 5% per mile travel allowance to and from his place of residence if he furnishes his own transportation; that when he attends other authorized meetings off the Reservation as directed by the Chairman, he will receive \$10.00 per diem to cover living expenses; plus 5% a mile travel allowance when he furnishes his own transportation; and when engaged on any other tribal business he will receive only travel allowance if he furnishes his own transportation; and

LET IT HE FURTHER MESOLVED that any such amounts are to be paid from available per diem and travel expenses as authorized in the annual budget of the Propage Tribe, or special Resolution passed by the Tribal Council, both of which are subject to Hurcau of Indian Affairs approval and to be supported by properly receipted bills showing the expenses have been made.

The foregoing resolution was on February 6, 1959, duly enacted by a vote of 21 for and 0 against by the Papago Council, at a meeting at which a quorum was present, nursuant to sufforty vested in it by Section 3 (a) Article V of the Constitution of the Tribe ratified by the Tribe on Recember 12, 1936 and approved by the Secretary of the Interior on Jenuary 6, 1937, pursuant to Section 16 of the Act of June 16, 1934 (48 Stat. 964). Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to the rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
