RESOLUTION  
OF THE  
PARAGO COUNCIL

RES. NO. 1073

WHEREAS, The Rodeo Board met on September 10, and considered a budget for the Rodeo to be held October 24 and 25, and submitted the following budget, signed by Chairman Johnny Blaine and acting Treasurer, C. J. Higman:

Labor, including special policemen, judges, pickup men, announcer, services of councilmen, stockmen, chairman's expense, and miscellaneous wages	550.00
Printing—posters, tickets, ribbons	90.00
Pennants and miscellaneous supplies	200.00
Weather insurance (estimated premium)	150.00
Rental of 85 head of livestock, hauling and feeding	1,160.00
Repairs to grandstand, chutes, gates, and booths, plus painting if possible	1,000.00
Orchestra for dances	100.00
Prizes for wild horse race	30.00
Miscellaneous expense	200.00
Total	<u>\$3,480.00, and</u>

WHEREAS, Although this budget is over twice the budget of last year, last year's budget was not realistically figured, and actual expenses were \$2,128.75, and most of the increase above this amount is accounted for by a provision of \$1,000.00 to repair stands and other facilities, which is necessary, and

WHEREAS, The Rodeo Board presently has \$1,521.10 on hand, and last year's gross receipts were \$3,177.77 and it can be expected that this year's rodeo receipts should be approximately the same, so the Board considers this is a reasonable budget, and will make every effort to reduce the amount of expenditures wherever possible.

THEREFORE LET IT BE RESOLVED by the Parago Council that the Rodeo Board budget as submitted be approved and the Treasurer be authorized to issue vouchers as required.

The foregoing Resolution was on September 11, 1959, duly enacted by a vote of 19 for and 0 against by the Parago Council, at a meeting at which a quorum was present, pursuant to authority vested in it by Section 3 (a) Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936 and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 16, 1934, (48 Stat. 924). Said Resolution is effective as of the date of its approval by the Superintendent

of the Papago Agency and is subject to the rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
