

RESOLUTION
OF THE
PAPAGO COUNCIL.

RES. NO. 1075

WHEREAS, The resignation of John Pedro Garcia, and now the resignation of John Harvey, have left vacancies in the Law and Order Department, one of which was filled on a temporary basis by Clara Acosta, and

WHEREAS, Pauline Siquieros applied for the other vacancy and was appointed on a temporary basis on August 25, 1959, and

WHEREAS, It appears on investigation that the work being done by the two girls in the Law and Order Department is about equally divided and they have equal responsibility, so instead of having a Chief Clerk and Assistant Clerk, it would be better to have a Law and Order Clerk and a Tribal Court Clerk, who should receive approximately the same salary depending on their experience and training, and

WHEREAS, Clara Acosta has had a year in business college and Pauline Siquieros has had a year in Junior College, and their experience is about the same, so it appears to be fairest if they get the same salaries to begin with, and,

WHEREAS, It has been recommended to the Council that they both begin at \$155.00 a month with the provision they can receive a raise of \$10.00 a month at the end of a three months period if their work is satisfactory, and

WHEREAS, The head of Law and Order believes Pauline is dependable and trustworthy, and the Council does not feel she should be deprived of an opportunity to work for the Tribe because of her relationship to Evelyn Siquieros, and

WHEREAS, A representative of the bonding company has been notified of all details of the hiring of Pauline Siquieros, and is contacting his Los Angeles Office for final approval to bond her.

WHEREFORE, LET IT BE RESOLVED by the Papago Tribal Council that Clara Acosta be appointed Tribal Court Clerk, and Pauline Siquieros be appointed Law and Order Clerk, their salaries to begin at \$155.00 per month effective September 1, 1959, and the Council authorizes the Chairman to approve raises, if not more than \$10.00 a month at the end of a three month's period if he considers their work to be satisfactory, the raises not to increase the salary beyond a maximum of \$195.00 per month without Council approval, and if the bonding company refuses to bond Pauline Siquieros, the Council can take appropriate action at the next meeting.

The foregoing Resolution was on September 11, 1959, duly enacted by a vote of 19 for and 0 against by the Papago Council pursuant to authority vested

in it by Section 3 (a) & (b) of Article V of the Constitution of the Tribe ratified by the Tribe on December 12, 1936 and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934, (48 Stat. 934). Said resolution effective as of the date of its approval by the Superintendent of the Papago Agency, and is subject to the rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
