

RESOLUTION  
OF THE  
PAPAGO COUNCIL

RES. NO. 1097

WHEREAS, Trans-Arizona Resources, 201 East 4th Street, Casa Grande, Arizona, represented by George Freeman, has applied for a Right of Way 20 feet wide to install a 3½" natural gas pipe line to extend between El Paso Natural Gas Company's main pipe line and the Lake Shore Mine, a distance of approximately 12.15 miles, all as described in Trans-Arizona Resources' application of February 23, 1960, and

WHEREAS, This gas line will be used to supply natural gas to operate furnaces for the treatment of ores at the Lakeshore Mine, the ores coming from Trans-Arizona Resources' patented property and also from land leased to Trans-Arizona Resources by the Papago Tribe, and

WHEREAS, Trans-Arizona Resources' application states it agrees to construct the Right of Way in a workmanlike manner, to maintain it properly, and will restore the land as nearly as possible to its original condition after the pipe line is put in; it will indemnify the Tribe for any damages to life or property resulting from the use or occupancy of the Right of Way by Trans-Arizona Resources; it has agreed that the land can continue to be used for ordinary purposes by the Tribe, such as grazing; and at the meeting with the Sif Oldak District Council at which Mr. Freeman explained the application, he agreed to pay \$25.00 per mile for the Right of Way, which will be a total of approximately \$300.00 and

WHEREAS, Mr. Freeman also said the pipe line will be on the ground except where it crosses washes, in which case it will either be buried or suspended, and that it will be buried a minimum of 3 feet under any roads, and that it will be at least two miles from any village, and

WHEREAS, The Council feels that the success of the Lakeshore Mine is important to the economic development of the District and the Reservation and Mr. Freeman has promised to employ Papagos on any jobs they are qualified to fill, and

WHEREAS, The Sif Oldak District Council unanimously approved a Resolution authorizing the Right of Way at a District meeting held March 2, 1960.

THEREFORE, LET IT BE RESOLVED by the Papago Tribal Council that the application for the Right of Way is approved under the conditions outlined in this Resolution and the Superintendent of the Papago Agency may grant the Right of Way in accordance with applicable government regulations.

The foregoing Resolution was duly enacted by the Papago Council on March 4, 1960, with a vote of 21 for 0 against during a meeting at which a quorum was present, pursuant to authority vested in it by Article V, Section 2 (c)

and Section 3 (h) of the Constitution of the Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 16, 1934, (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to the rescission by the Secretary of the Interior, pursuant to Section 6 of article V of the Constitution and By-Laws of the Papago Tribe.
