

RESOLUTION
OF THE
PAPAGO COUNCIL

RES. No. 1164

WHEREAS, On April 7, 1961, the Papago Tribal Council passed Resolution 1163 approving the application of the U. S. Engineers to lease approximately 4 acres in the Sand Tank mountain area of Hickman District, in accordance with a letter of application made by the Engineers on February 24, 1961, the application having been first approved by the Hickman District at a meeting held March 31, 1961, and

WHEREAS, The U. S. Engineers later applied to increase one of the two parcels of land requested from an area of 400' X 400', to 600' X 600', the other parcel 100' X 100' which will be located approximately 1500 feet from the larger site and which was approved in the first Resolution, to remain unchanged in size, and

WHEREAS, The new, larger site is described as the SE 1/4 SW 1/4 SE 1/4, Section 2, T.10S., R. 20E., G.20N., Arizona, and

WHEREAS, Instead of 4 acres, the total area will now be 10.23 acres, for which a yearly rental of \$50.00 an acre or fraction thereof will be paid, and

WHEREAS, The Hickman District Council approved the application for the larger site at a meeting held April 25, 1961.

THEREFORE, LET IT BE RESOLVED BY The Papago Tribal Council that Resolution 1163 be amended to include the added acreage requested by the U. S. Engineers, provided the U. S. Engineers agree to pay a yearly rental of \$50.00 per acre or fraction thereof, the rental which will be \$550 a year, 1/2 to go to the Hickman District 1/2 to the tribe, to begin on the date the U. S. Engineers enter the land, and Let it further be Resolved that the Council request that the lease be processed with the approval of the Papago Agency.

The foregoing Resolution was duly enacted by the Papago Council on May 5, 1961, with a vote of 17 for, and 2 not voting, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (h) of Article V of the Constitution of the Papago Tribe, ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the act of June 18, 1934 (Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to the rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-laws of the Papago Tribe.
