## RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 1252

WHEREAS, Tribal Court Judge Cipriano Manuel has previously been granted annual vacation leave with pay by the Papago Council, and

WHEREAS, the Tribal Judge was appointed to his present position as Tribal Court Judge on October 23, 1959 by Council Resolution No. 1080, and

WHEREAS, the Tribal Court Judge maintains that during the years of 1960 and 1961 he requested an annual leave with pay, but that this was refused because the Council did not regard the Tribal Judge as a regular appointee of the Tribe, and

WHEREAS, Resolution No. 615 of the Papago Council provides that regular appointees of the Tribe shall be entitled to an annual leave which shall accrue at the rate of 10 hours per month of service with the Tribe or 15 days per annum and shall not exceed 15 days at any time, and that each regular appointee of the Tribe who is entitled to annual leave benefits shall be required to take all of the leave accrued each calendar year so as to clear annually any accrual that may result, and

WHEREAS, the annual leave now due to the Judge since the date of his appointment is computed at 260 hours figured as follows: 2 months for the calendar year of 1959. 12 months for the calendar year of 1960 and 12 months for the calendar year of 1961, making a total of 26 months or 260 hours, and

WHEREAS, this computation produces a result of 32% days leave now due to the Tribal Judge at his regular salary of \$20.00 per day, totalling \$650.00.

NOW, THEREFORE, LET IT BE RESOLVED, that the Papago Council hereby orders and directs that the sum of \$650.00, representing 32% days annual leave, be paid to Tribal Judge Cipriano Manuel, covering his total annual vacation leave due him since the date of his appointment and not including the current calendar year of 1962, and that the Treasurer of the Papago Tribe is hereby ordered and directed to pay such sum of \$650.00 to the said Cipriano Manual.

The foregoing Resolution was duly enacted by the Papago Council on June 1, 1962, with a vote of 18 for, 0 against, and 2 not voting, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (a) and Section 3 (h) of Article V of the Constitution and By-laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the Date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-laws of the Papago Tribe.
