RESOLUTION
OF THE
PAPAGO COUNCIL

RES. NO. 1283

WHEREAS, for the past several years the per diem pay of the Papago Tribal Councilmen for their attendance at Tribal Council meetings has been \$10 per day, and

WHEREAS, in recent years the matters coming before the Tribal Council for deliberation and disposition have been growing more and more important, and

WHEREAS, long agendas in recent Council meetings have required the Councilmen to remain in session till late at night and sometimes into the early hours of the morning and that the present volume of business handled by the Council is much larger than it was heretofore, and

WHEREAS, the members of the Tribal Council have been conscientious and diligent in the discharge of their duties as Councilmen and have approached all problems looking first to the eventual benefit and progress of the members of the Papago Tribe, and

WHEREAS, it is now several years since the per diem rate of the Tribal Councilmen has been changed, and the Tribal Council is desirous of increasing the per diem rate of pay for the Councilmen to \$20 per day for their attendance at Council meetings, together with the present rate of mileage for such attendance, and

WHEREAS, on October 23, 1959, by virtue of Tribal Resolution No. 1080, the Papago Tribal Council recommended to the Bureau of Indian Affairs that Cipriano Manuel be appointed Chief Judge of the Papago Tribal Court to serve 5 days a week and that his salary be \$100 a week, which would result in a daily rate of \$20, and

WHEREAS, Judge Manuel has served the Tribe as Chief Judge of the Court since the date of the passage of the said Resolution without any increase in pay, and

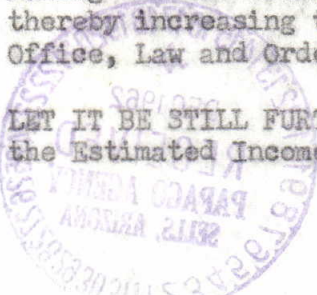
WHEREAS, Tribal Judge Manuel has served as Chief Judge of the Court in an exemplary manner and has performed his important duties in a conscientious and scrupulous manner and has performed his judicial services impartially and without bias, and

WHEREAS, the Tribal Council is desirous of increasing the daily wage rate of Tribal Judge Manuel in the amount of \$10 per day to make a total of \$30 per day.

NOW, THEREFORE, LET IT BE RESOLVED, that the Papago Council hereby orders and directs that the current 1963 Budget of the Tribal Office and Council be, and the same hereby is, amended by adding the sum of \$2,640 to the item: "Per diem and travel expenses for Tribal Council meetings, etc.", thereby making the new total of this item \$8,640.

LET IT BE FURTHER RESOLVED, that the Papago Council hereby orders and directs that the current 1963 Budget of the Law and Order Department be and the same is, hereby amended by adding the sum of \$1,850 to the item: "Tribal share of Judge's Salary, etc." thereby making the new total of this item \$4,850 plus the estimated Employer's share F.I.C.A., thereby increasing the Total Budget-Tribal Office and Council, Livestock Inspector's Office, Law and Order, and Rodeo Board from the previous total of \$72,520 to \$77,010.

LET IT BE STILL FURTHER RESOLVED, that the Papago Council hereby orders and directs that the Estimated Income of the current 1963 Budget be, and the same is, hereby amended by

adding the sum of \$4,490 to the item: "Law and Order Court Fines", thereby making the new total of this item \$12,490 and thereby increasing the Total Estimated Income from a previous total of \$45,500 to \$49,990.

LET IT BE STILL FURTHER RESOLVED, that all of the increases set forth previously in the within Resolution shall be retroactive and shall be effective as of October 12, 1962.

The foregoing Resolution was duly enacted by the Papago Council on December 7, 1962, with a vote of 17 for and 0 against, during a meeting at which a quorum was present, pursuant to Authority vested in the Council by Section 3 (a) and Section 3 (h) of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
