## RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 1289

GO COUNCIL

WHEREAS, George Freeman of the Lake Shore Mine originally leased 240 acres in the Sheridan Mountains in the Sif Oidak District on the Papago Indian Reservation, for which he paid the Tribe \$1,200 per year, and at the end of the year the said Freeman intended to cancel the lease but did not do so in time and he became liable for another year's rent in the amount of \$1,200, and

WHEREAS, Freeman then made a new offer to move to the Slate Mountains and take 240 acres, paying the same \$1,200 rent for this land and the Tribe agreed, giving a new lease to Freeman and he paying the \$1,200 rent and

WHEREAS, Freeman later wanted to modify the lease by dropping the 240 acres in the Slate Mountains and taking 40 acres in the Jackrabbit Wash, for which he effored to pay \$200, and the Tribe them advised Freeman that he would have to pay the full amount of \$1,400, this amount of \$1,400 being made up of \$1,200 which became due in April 1961 and \$200 for the 40 acres in Jackrabbit Wash, and

WHEREAS, the Council has fully considered this matter and is keeping in mind how the Tribe co-operated with Freeman in allowing him to switch his lease from Sheridan Mountains to Slate Mountains and in allowing him to take an additional 40 acres in Jackrabbit Wash, and

WHEREAS, the Sif Oidak District Council has passed a resolution, demanding that Freeman pay the full amount of \$1,400 now due to the Tribe.

NOW, THEREFORE, LET IT BE RESOLVED, that the Papago Council hereby orders and directs that George Freeman pay to the Papago Tribe at once the sum of \$1,400 now due to the Tribe as rentals of the locations in the Slate Mountains and in the Jackrabbit Wash.

The foregoing Resolution was duly enacted by the Papago Council on March 1, 1963, with a vote of 22 for and 0 against, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (h) of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to reseission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
