RESOLUTION
OF THE
PAPAGO COUNCIL

RES. NO. 1294

WHEREAS, the Papago Tribal Council, at its January 5, 1962 meeting, by virtue of Resolution No. 1212, voted to accept the offer of the Public Housing Administration to construct a Low Cost Housing Project upon the Papago Reservation and requested the Housing Administration to construct such project, and

WHEREAS, the said Papago Tribal Council subsequently and at its October 26, 1962 meeting, by virtue of Resolution No. 1280, voted to accept and to adopt in its entirety a Tribal Ordinance creating a Housing Authority and ordered and directed that the said Tribal Ordinance be made a part of the procedure to obtain the said Low Cost Housing Project, and

WHEREAS, legislation has recently been enacted providing for the construction, remodeling or enlarging of homes through the medium of a Self-Help Housing Project and it has been found necessary to amend the provisions of the original Tribal Ordinance in order to include and to embrace the required provisions for the said Self-Help Housing Project, and

WHEREAS, the Papago Council is desirous of obtaining for the members of the Papago Tribe the benefits and advantages accruing to them through the provisions of the Self-Help Project.

NOW, THEREFORE, LET IT BE RESOLVED, that the Papago Council hereby amends and modifies the Tribal Housing Ordinance accepted and adopted by the Council on October 26, 1962 by making the following additions to said Tribal Ordinance:

1. Article III, item e (2) on page 3 of the Ordinance should have the following inserted between the words "provide" and "decent":

" , or assist in providing (by any suitable method, including but not limited to: rental; sale of individual units in single or multifamily structures under conventional, condominium, or cooperative sales contracts; Lease-purchase agreements; loans; or subsidizing of rentals or charges)".

2. Article V, Section 2 i on page 6 of the Ordinance should have the following inserted in place of the words "or rent" in the first sentence:

" , rent, sell, or lease with option to purchase".


LET IT BE FURTHER RESOLVED, that with the inclusion of the amendment as above set forth, the Papago Council hereby re-accepts and re-adopts in its entirety the said Tribal Ordinance creating a Housing Authority and orders and directs that the said Tribal Ordinance, as amended, be made a part of the procedure to obtain the said Low Cost Housing and Self-Help Housing Projects.


The foregoing Resolution was duly enacted by the Papago Council on April 5, 1963, with a vote of 19 for, 0 against, and 2 not voting, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 2 (a) and Section 2 (h)

of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934.
