RESOLUTION
OF THE
PAPAGO COUNCIL

RES. NO. 1296

WHEREAS, Tribal Chairman Eugene J. Johnson attended the Meeting of the Executive Committee of the National Congress of American Indians in Washington, D. C. from March 4th through March 8th, and

WHEREAS, the Tribal Chairman had not planned on attending the said Meeting until the Tribal Chairman conferred with U. S. Commissioner Nash on the occasion of the Commissioner's visit to the Papago Reservation on March 1st through March 4th, and

WHEREAS, Commissioner Nash suggested to the Tribal Chairman that the Chairman attend the said meeting and it was the opinion of the Commissioner that such attendance by the Chairman in Washington would prove of great benefit to the Papago Tribe, and

WHEREAS, the decision of the Tribal Chairman to attend such Meeting was not reached until following the March 1, 1963 meeting of the Council and there was no opportunity to present the matter to the Council prior to the date of the Executive Committee Meeting, and

WHEREAS, the complete expenses of the Tribal Chairman's trip amounted to \$459.00, and

WHEREAS, the Council is of the opinion that the trip taken by the Tribal Chairman will prove of great benefit to the Papago Tribe and will create certain prestige among the other member tribes of the National Congress and among certain federal and governmental officials in Washington which will redound to the eventual benefit, welfare and advantage of the Papago Tribe.

NOW, THEREFORE, LET IT BE RESOLVED, that the Papago Council hereby bestows its complete approval on the trip to Washington, D. C. taken by the Tribal Chairman in attending the Executive Committee Meeting of the National Congress of American Indians, and also approves the expenditure of \$459.00 which amount represents the complete expenses of the Tribal Chairman in making such trip.

LET IT BE FURTHER RESOLVED, that the Papago Tribal Treasurer is hereby ordered and directed to pay up to the amount of \$459.00 all of the expenses and expenditures of the Tribal Chairman in attending the said Meeting in Washington, D. C.

The foregoing Resolution was duly enacted by the Papago Council on April 5, 1963, with a vote of 20 for and 0 against, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (a) of Article V of the Constitution, and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
