

RESOLUTION  
OF THE  
PAPAGO COUNCIL

RES. NO. 1304

WHEREAS, the Tribal car, which is now used by the Tribal Chairman and by various employees of the Tribal Office was purchased new in May 1961, being a 1961 model Chevrolet 4-door Biscayne automobile, and

WHEREAS, said Tribal car has now been driven in excess of 67,000 miles and has been appraised for turn-in value on the purchase of a new automobile by O'Rielly Chevrolet Company of Tucson, and

WHEREAS, the sum of \$1,000.00 will be allowed by the O'Rielly Company as a credit for the old automobile upon the purchase of a new 1963 model 4-door Chevrolet Biscayne, the new car costing \$2,629.20, exclusive of tax, if necessary, and plates, and including manual radio, tinted glass and heavy duty radiator, and

WHEREAS, the Papago Council believes it would be beneficial to the Tribe to purchase a new car at this time for the reason that the old car is deteriorating quickly and is weekly costing various sums for repairs and replacement and the Council believes that these expenditures will continue as long as the Tribe retains possession of the old car.

NOW, THEREFORE, LET IT BE RESOLVED, that the Papago Council hereby orders and directs that the Tribe immediately purchase a new 1963 model Chevrolet 4-door Biscayne automobile from O'Rielly Chevrolet Company of Tucson at a purchase price of \$2,629.20, exclusive of tax, if necessary, and plates, and including manual radio, tinted glass and heavy duty radiator, thereby taking advantage of the credit of \$1,000.00 turn-in credit on the old 1961 model Chevrolet automobile now owned by the Tribe.

LET IT BE FURTHER RESOLVED, that funds for the purchase of the said automobile shall be taken from the Tribal Office expense account of the Tribal Office and Council Budget for the 1963 fiscal year.

The foregoing Resolution was duly enacted by the Papago Council on May 3, 1963, with a vote of 19 for and 0 against, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (a) and Section 3 (h) of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of the Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
