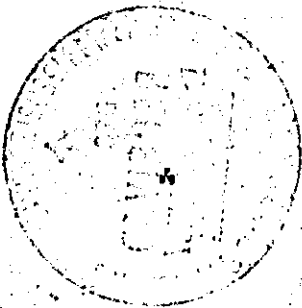

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 1502

WHEREAS, the Sif Oidak District Council passed the following resolution at a District meeting held November 9, 1966, at which a quorum was present, and

WHEREAS, the Sif Oidak District Council had \$56,253.53 in its District IIM Account in the Papago Agency on November 30, 1966, and

WHEREAS, the District Council approved a budget of \$11,000.00 for the 1967 Fiscal Year, leaving a surplus funds of approximately \$45,253.53 in the Sif Oidak District Account after providing for possible additional expense to the end of the Fiscal Year, and

WHEREAS, the District Council wishes to deposit \$30,000.00 in the Valley National Bank in Casa Grande, Arizona so the funds will earn the regular rate of interest on which such accounts, which is now 5%, instead of sitting idle in the agency account, and

WHEREAS, the members of the Sif Oidak District Council considering this matter have selected in accordance with District procedure, and the Chairman, who has been properly selected by the District Council.

THEREFORE, LET IT BE RESOLVED BY the Sif Oidak District Council that \$30,000.00 be transferred from the Sif Oidak District IIM Account in the Papago Agency and be deposited in an insured savings account in the office of the Valley National Bank in Casa Grande, Arizona and that Mr. John Artichoker Jr., Superintendent of the Papago Agency, be designated by the District to act as trustee of this savings account, making deposits to it from the IIM Account or withdrawals to be placed in the IIM Account, in accordance with resolution properly passed by the Sif Oidak District Council.

THEREFORE, LET IT BE RESOLVED by the Papago Council that it approve the Resolution of the Sif Oidak District Council, and that it recommend that Sif Oidak District deposit its surplus funds in the manner above outlined.

The foregoing resolution was duly enacted by the Papago Council on December 16, 1966 with a vote of 19 for and 0 against, during a meeting at which a quorum was present, pursuant to authority vested in it by Article V, Section 3 (a) and (h) of the Constitution of the Constitution of the Tribe ratified on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
