RES. NO. 1523

The foregoing Resolution was duly enacted by the Papago Tribal Council on June 2, 1967, with a vote of 15 for, 0 against, with 1 not voting, during a meeting at which a quorum was present, pursuant to authority vested in the Council by Section 3 (1) of Article V of the Constitution and By-Laws of the Papago Tribe, ratified by the Tribe on December 12, 1936 and approved by the Secretary of Interior on January 6, 1937 (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to rescission by the Secretary of Interior pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.
