



- C. To receive from project supervisors time and attendance reports of persons who work.
- D. To prepare vouchers for assistance grants for issuance of weekly checks to persons certified as eligible by Agency welfare and in the amount determined by the Agency.
- E. To provide an industrial compensation plan from Tribal funds on the same scale as for other Tribal employees.
- F. To provide the staff for processing applications, payments and time and attendance reports.

BE IT FURTHER RESOLVED that the Tribal Chairman is authorized to take whatever action necessary to implement said program, and he is further authorized to execute the appropriate legal documents.

The foregoing resolution was duly enacted by the Papago Council on June 16, 1967, with a vote of 21 for, 0 against, with 1 not voting, at a meeting at which a quorum was present, pursuant to authority vested in the Council by Sections 2 (h) and 3 (h) of Article V of the Constitution and By-Laws of the Papago Tribe ratified by the Tribe on December 12, 1936 and approved by the Secretary of Interior on January 6, 1937 (Stat. 984), pursuant to Section 16 of the Act of June 18, 1934. Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to recession by the Secretary of Interior, pursuant to Section 6 of Article V of the Constitution and By-Laws of the Papago Tribe.

RESOLUTION OF THE PAPAGO TRIBAL COUNCIL

RES. NO. 1530

WHEREAS, the Papago Indian Agency of the Bureau of Indian Affairs proposes to contract with the Papago Tribe for the purchase of services involved in the administration of general assistance to employable persons on the Papago Reservation, and

WHEREAS, the purpose of this program is to expand the opportunities for constructive work experience and other needed training available to persons who are unable to support or care for themselves or their families due to lack of employment opportunities, and

WHEREAS, the Papago Tribe and the Papago Indian Agency have agreed on the responsibilities of each party to said program.

NOW, THEREFORE, LET IT BE RESOLVED that the Papago Tribal Council agrees to enter into a contract with the Bureau of Indian Affairs with each of the parties agreeing to some of the following responsibilities:

- I. The responsibility of the Agency will be:
 - A. To take applications, determine eligibility and amount of grants.
 - B. To set up a special Tribal IIM account to be used for issuance of assistance checks and administrative costs of this program, excluding the coverage of Industrial Compensation insurance.
 - C. To pay administrative costs to the Tribe.
 - D. To develop a mental hygiene program in collaboration with the Tribe.
- II. The responsibility of the Tribe in collaboration with the Agency will be:
 - A. To establish work projects and arrange for supervisors.
 - B. To arrange with project supervisors and assignment of persons who are certified as eligible.
