

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 24-69

WHEREAS; The Department Heads and the Chairman of the several Boards and Committees of the Papago Tribal Government have prepared their Departmental, Board and Committee budgets for Fiscal Year 1970, and

WHEREAS; The Budget Committee has reviewed these Department, Board and Committee budgets and has recommended reductions in salaries and staff positions and operations in these areas which will less seriously affect the operations of the Papago Tribal Government so that savings may be affected to allow The Papago Council to appropriate monies to The Papago Tribe-Livestock Relief Fund, for the purposes of purchasing supplemental livestock feed, water troughs and water hauling, fencing supplies for control fencing, tools and equipment, veterinary supplies, and emergency well repairs and maintenance, and

WHEREAS; The Papago Council has carefully reviewed the proposed budget and feels that the Department Heads, Board and Committee Chairmen, and the Budget Committee have carefully considered the present and future needs of the Tribe, its income potential and other relevant factors and have therefore presented what is considered to be a reasonable budget, and

WHEREAS; The Papago Council recognizes that the proposed budget, as a plan for the future use of Tribal income, may of necessity change as circumstances occur during the fiscal year and therefore, reaffirms its right to amend the budget to give effect to changed conditions,

THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL; That the Budget of The Papago Tribe for the Fiscal Year 1970 is hereby approved and adopted, as presented;


PROVIDED; That the Treasurer of The Papago Council is hereby authorized to approve expenditures in amounts not to exceed those in the approved budget, and that the Treasurer is charged with the responsibility to keep The Papago Council aware of any conditions which may necessitate a change in the approved budget, and that the Treasurer of The Papago Council is under no circumstances authorized to expend amount in excess of the individual Department, Board and Committee budgets without first securing the approval of The Papago Council for the budget amendment deemed necessary, and

BE IT FINALLY RESOLVED; That the Tribal monies derived from all income during Fiscal Year 1970 which will be deposited in the U.S. Treasury be made available immediately after receipt to finance operations of the program as recommended in the budget and that such funds be hereby considered allotted Trust Funds subject to the withdrawal by the Tribal Treasurer upon proper execution of Standard Form 1034, including therein reference to this blanket resolution.


The foregoing Resolution was duly enacted by The Papago Council on the 30th day of June, 1969, at a meeting at which a quorum was present with a vote of 16 for, 0 against, and 4 absent, pursuant to authority vested in The Papago Council by Section 3 (a), of Article V, of the Constitution and By-Laws of The Papago Tribe of Arizona ratified by The Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, (48 Stat. 984) pursuant to Section 16 of the Act of June 18, 1834. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior pursuant to Section 3 of Article V, of the Constitution of The Papago Tribe.
