

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 30-69

WHEREAS; The Papago Office of Economic Opportunity held Public Board Meetings on August 14 and 15 and September 3 and 4, 1969, to give the Papago People an opportunity to review, evaluate, and improve their O.E.O. Programs and organization, and

WHEREAS; Many Papagos representing The Papago Council, the 11 District Councils, Livestock Associations, Round-Up Organizations, Women's Clubs, Fiesta Committees, Ceremonial Committees, Parents Committees, and School Administrators and representatives of Federal, State and local agencies, attended and actively participated in the meetings, and

WHEREAS; After considerable discussion and due consideration the Papago People have submitted their evaluation of the Papago OEO Programs and their recommendations as to how the Program might be improved and their requests for additional monies for such Program improvements and expansions, in accordance with the expressed needs of the Papago People, and

WHEREAS; The Papago O.E.O. Board of Directors, Executive Director of staff and the Papago O.E.O. have submitted the recommendations and requests from the Papago People to The Papago Council for its consideration with the request that every effort be made to obtain funding for the requested expanded Community Action Programs.

THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL; That the following additions be made to the proposed budgets of the Community Action Programs in accordance with the expressed needs and wishes of The Papago People and that the expanded Community Action Programs are hereby approved and transmitted to the Office of Economic Opportunity in Washington, D.C. for its review and funding:

a. Community Organization

1 - Associate Director

2 - O.E.O. Board of Directors' meetings per month

Expanded Total - \$72,343.00

b. Community Centers

1 - Associate Director for Community Development

2 - Supervisors for Community Development

- 8 - Community Development Workers for the Communities of Meneger's Dam, PiOik, Santa Cruz, Pisinemo, Sells, Topawa, and Chukut Kuk and Sif Oidak Districts.

Expanded Total - \$211,618.00

c. Head Start

1. Additional Pre-School classrooms at San Xavier, Sells, Pisinemo and Chuichu, and new Pre-School Classrooms at Santa Rosa Ranch, Topawa, and San Lucy Communities. It may be necessary to resort to mobile units or other means for classrooms.
2. Parent-Child Centers in all of the Pre-School Center areas: San Xavier, Santa Rosa Ranch, Topawa, Sells, Santa Rosa, Pisinemo, Vaya Chin, Chuichu, and San Lucy Communities.

Expanded Total - \$369,380.00

TOTAL OF EXPANDED COMMUNITY ACTION PROGRAMS----\$653,341.00


BE IT FINALLY RESOLVED; That the Office of Economic Opportunity is hereby urged to exert every effort to meet these expressed needs of The Papago People.


The foregoing Resolution was duly enacted by The Papago Council on September 9, 1969, at a meeting at which a quorum was present with a vote of 15 for, 0 against, and 7 absent, pursuant to authority vested in The Papago Council by Section 2(a) of Article V, of the Constitution and By-Laws of The Papago Tribe of Arizona ratified by The Papago Tribe on December 12, 1936 and approved by the Secretary of the Interior on January 6, 1937, (48 Stat. 984) pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is not subject to review by the Secretary of the Interior.
