

RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 39-69

WHEREAS; The Papago Council enacted Resolution No. 24-69 on June 30, 1969, approving and adopting the Budget of The Papago Tribe for the Fiscal Year 1970, and

WHEREAS; Upon the recommendation of the Budget Committee reductions were made in salaries, staff positions and operations in those areas which would less seriously effect the operations of The Papago Tribal Government so that the adopted operating Budget would come within the limits of the expected income, and

WHEREAS; The Papago Council recognized that the adopted budget, as a plan for the future use of Tribal income, may of necessity change as circumstances occur during the fiscal year and therefore, reaffirmed its right to amend the budget to give effect to changed conditions, and

WHEREAS; The Department Heads and the Chairmen of the several Boards and Committees of the Papago Tribal Government have revised the Department, Board and Committee budgets in accordance with their anticipated needs for the balance of Fiscal Year 1970 and have submitted them to The Papago Council for its review, and

WHEREAS; The Papago Council has carefully reviewed the proposed revisions to the Budget for Fiscal Year 1970 and feels that, in view of changed circumstances affecting the present and future needs of the Tribe and the greater income potential and other relevant factors, the proposed budget is a reasonable one;

THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL; That the Budget of The Papago Tribe for the Fiscal Year 1970, as revised, is hereby approved and adopted;

PROVIDED; That the Treasurer of The Papago Council is hereby authorized to approve expenditures in amounts not to exceed those in the approved Budget, and that the Treasurer is charged with the responsibility to keep The Papago Council aware of any conditions which may necessitate a change in the approved Budget, and that the Treasurer of The Papago Council is under no circumstances authorized to expend amounts in excess of the individual Department, Board and Committee budgets without first securing the approval of The Papago Council for the budget amendment deemed necessary, and




BE IT FINALLY RESOLVED; That the Tribal monies derived from all income during Fiscal Year 1970 which will be deposited in the U.S. Treasury be made available immediately after receipt to finance operations of the Program as recommended in the budget and that such funds are hereby considered allotted Trust Funds subject to the withdrawal by the Tribal Treasurer upon, proper execution of Standard Form 1034, including therein reference to this blanket resolution.

The foregoing Resolution was duly enacted by The Papago Council on October 17, 1969, at a meeting at which a quorum was present with a vote of 21 for, 0 against, and 1 absent, pursuant to authority vested in The Papago Council by Section 3 (a) of Article V of the Constitution and By-Laws of The Papago Tribe of Arizona ratified by The Papago Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984). Said Resolution is effective as of the date of its approval by the Superintendent of The Papago Agency and is subject to review by the Secretary of the Interior.
