WHEREAS; The 26th Annual Convention of the National Congress of American Indians will be held in Albuquerque, New Mexico, on October 6 through 10, 1969, and

WHEREAS; This year's Annual Convention marks the 25th anniversary of the National Congress of American Indians, which has grown to become the major spokesman for the Indian people on the national scene, representing over 350,000 American Indians and 105 member tribes, and

WHEREAS; This 26th Annual Convention more than any previous convention is being regarded as a Summit Conference of the Indian People at which a discussion of the issues and challenges that face the Indian people will be held, and charting of a course will be made for the days ahead, and

WHEREAS; The Papago Tribe is a member of the National Congress of American Indians and the Papago Council feels it would be in the best interest of the Tribe to send a delegation to said convention to represent The Papago Tribe;

THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL; That it hereby appoints a delegation consisting of Thomas A. Segundo, Chairman; Elee R. Sam, Vice-Chairman; Phillipa A. Jose, Secretary; Elena Frank, Councilwoman; Joseph Enriquez, Councilman; Raymond Narcho, Councilman; Louis Harvey, Sr., Councilman; Willard Andrews, Councilman; Vincent Manuel, Councilman; Dewey Ortega, Councilman; Mabel P. Antone, Judge, The Papago Tribal Court; George F. Norris, Captain, The Papago Police; Rolf W. Bauer, Executive Director, Papago O.E.O.; Maryann Wilson, Director, Emergency Food & Medical Supply Programs; Phillis Antone, Papago Pre-School teacher; Simon Lopez, Supervisor, Papago Community Development Program; Henry Manuel, Lay Counselor, Papago Legal Services Program; and Della Antone, Secretary, San Xavier District Council; and

BE IT FURTHER RESOLVED; That The Papago Council hereby authorizes the appropriation of funds to cover the expenses, including transportation, of the delegates to the convention.

The foregoing Resolution was duly enacted by The Papago Council on September 26, 1969, at a meeting at which a quorum was present with a vote of 19 for, 0 against, and 3 absent, pursuant to authority ested in The Papago Council by Section 2 (f) and Section 3 (a) of Article V, of the Constitution and By-Laws of The Papago Tribe of Arizona ratified by The Papago Tribe on December 12,1936, and approved
