WHEREAS, the Papago Tribal Council did, by Resolution No. 1212, passed on January 5, 1962, charter the Papago Tribal Housing Authority with authority to secure HUD-financed housing on the Papago Reservation; and

WHEREAS, the San Xavier District Council has requested the Papago Housing Authority to secure HUD-financed housing for residents of the San Xavier District; and

WHEREAS, the Papago Tribal Housing Authority has recommended use of the following described tribal reserved land for construction of HUD-financed housing for residents of the San Xavier District who do not have alloted land on which to build their homes, to-wit:

TR2 SE4NW4SE4 and SW4NE4SE4, Section 23; Township 15 South; Range 13 East; G&SRB&M, Pima County, Arizona, containing approximately 20 acres; and

WHEREAS, the applicants for such housing have indicated their preference for said land as home sites; and

WHEREAS, said land is presently classified as tribal reserved land by Order dated February 9, 1931, for purpose of erecting a sanitarium; and

WHEREAS, said land was never used for such purpose; and

WHEREAS, the San Xavier District Council, by Resolution No. 73-2, passed on September 16, 1973, (a copy of which is attached hereto), has requested the Papago Council to revoke the above Order, to restore the above described land to the Papago Tribe, and to direct that it be used for the purpose of constructing HUD-financed houses for the Papago people.

NOW, THEREFORE, BE IT RESOLVED BY THE PAPAGO COUNCIL that the Order of this Council dated February 9, 1931, is hereby revoked to the extent that it limits the use of the following described tribal reserved land to a sanitarium site, and said land is hereby unreservedly restored to the Papago tribe, said land being described as follows, to-wit:

TR2 SE¼NW¼SE¼ and SW¼NE¼SE¼, Section 23; Township 15 South; Range 13 East; G&SRB&M, Pima County, Arizona, containing approximately 20 acres.

BE IT FURTHER RESOLVED that said land be used for the purpose of HUD-financed housing in accordance with the attached Resolution of San Xavier District Council.

The foregoing resolution was duly enacted by the Papago Council on the 24 day of Sent, 1973, at a meeting at which a quorum was present with a vote of 20 for; O against; O not voting; and 1 absent, pursuant to authority vested in the Papago Council by Sections 2(c), (h) and 3(h) and (k) of Article V of the Constitution and By-Laws of the Papago Tribe of Arizona, ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934. Said resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
