## RESOLUTION OF THE PAPAGO COUNCIL

RES. NO. 42-75

WHEREAS, Resolution No. 1239, adopted May 4, 1962, approved and supported construction of a multi-purpose dam and reservoir on the Santa Rosa Wash approximately six and one-half (6 1/2) miles upstream from Vaiva Vo, Arizona; and

WHEREAS, 5328.78 acres were donated by the Papago Tribe for this project which consist of the maximum area that would be covered by water except during the once every 400 year period; and

WHEREAS, according to the Army Corp of Engineers, 9,080.92 acres are included in the area that would or could be covered by water once every 400 years; and

WHEREAS, the Papago Tribe would have the full control and use of said 9,080.92 acres except when covered by said flood waters; and

WHEREAS, the appraised value for the taking of said 9,080.92 acres during the once every 400 years flood time is THREE HUNDRED FORTY THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$340,750.00) which the Army Corp of Engineers has offered as compensation to the Papago Tribe of Arizona; and

WHEREAS, the Tat Momoli village had to be relocated due to the fact that the site of said village fell within the possible flood area; and

WHEREAS, the appraised value of the structure in said village is EIGHT THOUSAND FOUR HUNDRED SIXTY FIVE DOLLARS (\$8,465.00); and

WHEREAS, Sif Oidak District Council has passed a resolution accepting the THREE HUNDRED FORTY NINE THOUSAND TWO HUNDRED FIFTEEN DOLLARS (\$349,215.00), provided that ONE HUNDRED SEVENTY THOUSAND THREE HUNDRED SEVENTY FIVE DOLLARS (\$170,375.00) be allocated to the Papago Tribe; ONE HUNDRED SEVENTY THOUSAND THREE HUNDRED SEVENTY FIVE DOLLARS (\$170,375.00) be allocated to the SIF OIDAK DISTRICT and EIGHT THOUSAND FOUR HUNDRED SIXTY FIVE DOLLARS (\$8,465.00) be allocated to the people of Tat Momoli village in accordance to the valuation of their individual structures; and

WHEREAS, it is in the best interest of the Papago Tribe to accept the THREE HUNDRED FORTY NINE THOUSAND TWO HUNDRED FIFTEEN DOLLARS (\$349,215.00) as compensation for the taking of said land.

NOW, THEREFORE, BE IT RESOLVED that the Papago Tribe of Arizona hereby accepts the sum of THREE HUNDRED FORTY NINE THOUSAND TWO HUNDRED FIFTEEN DOLLARS (\$349,215.00) as full compensation for the taking of the possible use of 9,080.92 acres during excessive flood period and as further full compensation for the relocation of the Tat Momoli Village.

BE IT FURTHER RESOLVED that the THREE HUNDRED FORTY NINE THOUSAND TWO HUNDRED FIFTEEN DOLLARS (\$349,215.00) received as compensation be divided as follows:

- 1. \$170,375.00 to the Papago Tribe of Arizona.
- 2. \$170,375.00 to the Sif Oidak District.
- 3. \$8,465.00 to the people of Tat Momoli Village in accordance to the valuation of their individual structures that were lost due to the relocation of said village.

BE IT FURTHER RESOLVED that the Superintendent of the Papago Tribe of Arizona distribute immediately said compensation when received as set forth hereinabove.

BE IT FURTHER RESOLVED that the Chairman, Vice-Chairman and the Secretary of the Papago Tribe be and they are hereby authorized to execute all

necessiry documents and instruments and to take all necessary action to carry out the intent and terms of this Resolution.

The foregoing Resolution was duly enacted by the Papago Council on the 22nd day of July ,1975, at a meeting at which a quorum was present with a vote of 12 for; 8 against; 2 not voting; and 0 absent; pursuant to authority vested in the Papago Council by Section 2 (2) and 3 (a), (h) and (k) of Article V of the Constitution and By-laws of the Papago Tribe of Arizona ratified by the Tribe on December 12, 1936, and approved by the Secretary of the Interior on January 6, 1937, pursuant to Section 16 of the Act of June 18, 1934. Said Resolution is effective as of the date of its approval by the Superintendent of the Papago Agency and is subject to review by the Secretary of the Interior.
